



CONTEST RULES

The contest “***Enhance the look of your home and save big time!***” is conducted by Maibec Inc. The contest takes place across Quebec, Ontario, New Brunswick, Nova Scotia and Prince Edward Island, and runs from February 7, 2019 at 8:00 a.m. EST (Eastern Standard Time) to May 31, 2018 at 4:30 p.m. EST (contest period). Eligible participants have the chance to win back the value of their purchase of Maibec Resistech Natural tones siding purchased from a Maibec retailer, up to a total amount of \$5,000.

Who can enter

To be eligible, you must be at least eighteen (18) years or older and own a registered home in Quebec, Ontario, New Brunswick, Nova Scotia or Prince Edward Island, where Maibec Resistech products are available.

You are not eligible to enter the contest if, at any moment during the contest period, you are (or are residing with) a Maibec employee, agent, distributor, retailer, administrator or representative.

To enter

To enter, you must fill out the online entry form available at maibec.com.

All contest entry forms and participation requests must be received by Maibec within the contest period to be eligible.

Maximum of one (1) entry per residence. In the event that a participant has more than one residence with Maibec siding, each residence is eligible for the contest and must be entered separately. The prize will be awarded only to the home that was entered and drawn in the contest.

Description of the prize

The winner will receive a check reimbursing them for the cost of their Maibec Resistech material up to a total amount of \$5,000, as indicated on the invoice, excluding any taxes, delivery fees and installation costs, which are the sole responsibility of the winner. To claim the prize, the winner must provide Maibec with a copy of the invoice (dated February 7, 2019 or later) within one (1) year of being declared the winner. Reimbursement will be made by check in Canadian funds.



Awarding of the prize

The draw will be held on June 14, 2019 at 2:00 p.m. EST (Eastern Standard Time). The draw will take place at Maibec's office, located at 202-1984 5^e rue, Lévis, Quebec, Canada, G6W 5M6. The randomly selected participant will be declared the winner provided they fulfill all of the contest eligibility conditions and entry requirements. The winner will be contacted by telephone in the week following the draw and must claim the prize within a maximum period of 14 days. If the prize is not claimed within this period, or if the winner cannot be reached within 14 days of the draw, the selected participant will be disqualified and another name will be randomly drawn until a winner has been confirmed. Maibec will ship the prize to an address in Québec, Ontario, New Brunswick, Nova Scotia or Prince Edward Island, in the manner it deems satisfactory.

The selected individual agrees to release and hold harmless Maibec, its subsidiaries, promotional agencies, partners, employees, agents and authorized dealers from and against any damages arising out of the receipt or use of the prize. To be declared a winner and prior to receiving the prize, the selected individual agrees to sign a declaration and liability release for this purpose.

General rules
